Times:	Warm ups begin at 7:00am Coaches meeting at 7:45am Meet officials/stroke & turn meeting at 8:00am First call at 8:30am Meet begins at 9:00am
Warm-ups and cool-downs:	Follow team warm-up schedule. All warm-ups and cool-downs must be supervised by a coach.
Rules:	CVRSL rules and regulations will govern the meet.
Entries:	The meet is pre-seeded from results submitted by all teams with heats running from slowest first to fastest last. Coaches may submit scratches at the 7:45am coaches meeting. Any swimmer who misses an individual event will be scratched from the next individual event.
Staging:	Only those swimmers that have been through the staging process will be allowed on the deck. Coaches are not allowed to meet with swimmers once on the deck. Please listen for first and second calls to get your swimmers to the staging area in time for their events. Tulare staging volunteers will line up the younger swimmers in the staging tent and on deck for all their events. Parents or coaches will not be allowed on deck to help.
Awards:	Awards will be distributed as specified in the CVRSL bylaws. Medals and ribbons will be available at the end of the meet for each team to pick up. Checks are made payable to CVRSL. Teams must pay in order to pick up their awards. Please come prepared!
Timers and Recorders:	Each team will provide 4 volunteers to time and record during their allotted time. Each team will have at least 1 lane with morning and afternoon sessions.
Submitting Grievances:	Any questions need to be submitted to the computer table within 60 minutes of the results being posted. The Head Coach is the only person who may submit a question.
T-shirts and Programs:	There will be no pre-order t-shirts. G.I.C. Graphic Wear will be on-site selling various clothing items. They will make up approx. 400 shirts to begin with and then make them as needed. Programs will be pre-sold for \$4. Team orders are due by Wed. July 8 th at 12pm.
Spectator Area:	Umbrellas and ice chests are not allowed in the spectator areas. See attached map of spectator areas.

Lunch Break:	There will be a 30 minute lunch break after event 46. There will be two concession stands...one near the bleachers and one out under the football stadium near Tent City. Concessions will be open all day and various food vendors will be on-site. Coaches and officials will receive a lunch ticket. Redeem for a lunch at the hospitality booth, located on the map. Pool will be open for warm-ups as long as there is a coach present.
Stoke and Turn:	Each team is responsible for providing two stroke and turn officials. They are to meet on deck for their meeting at 8am.
Coaches:	Four (4) deck passes will be given to each team. This will allow those coaches to sit in their designated team area on deck. Coaches are not allowed in the block area. Swimmer disqualification can occur if coaches violate the block area.

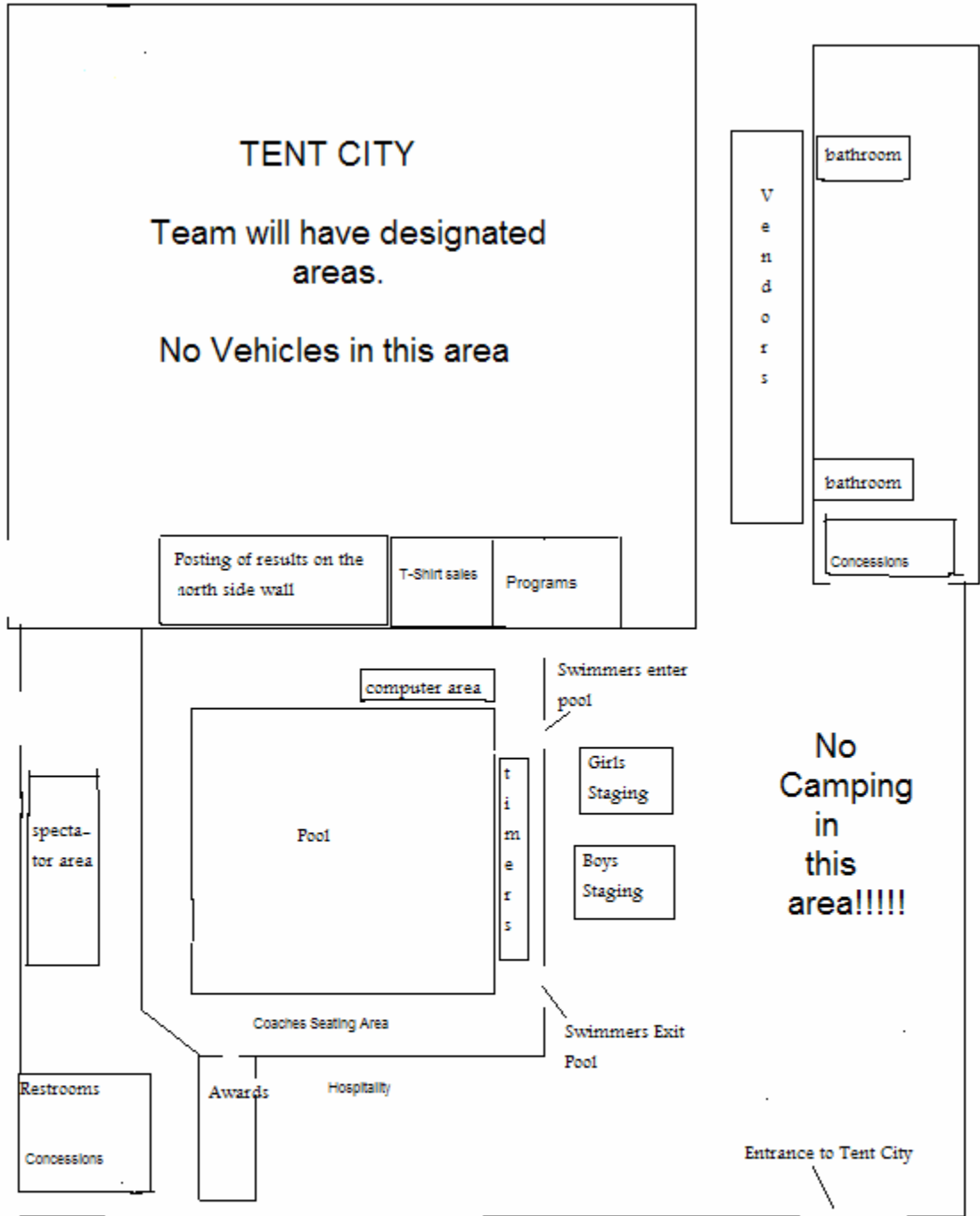
T-Shirt Information
